ADOPTION OF DISSOLUTION

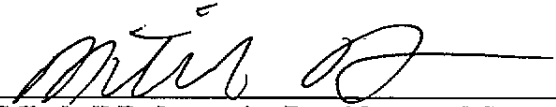
The dissolution of Corporation was approved by all of its shareholders and the entire board of directors. The number of votes cast for dissolution was sufficient for approval.
