The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I NAME**

The name of the corporation shall be Tampa Bay Computer Services, Inc.

**ARTICLE III PURPOSE**

The purpose for which this corporation is formed is to engage in the delivery of computer services, including Bulletin Board Systems, Online Services, and Internet Services, including consulting, to acquire, hold, maintain, and dispose of any property, real and personal, tangible and intangible, incidental to these activities, to borrow money, to create, issue, and discharge evidences of indebtedness, and to secure the same in any manner, to enter into agreements with any person, association, or corporation and to secure the performance of such agreements, to do any and all acts necessary to accomplishment of the foregoing.
