ARTICLES OF INCORPORATION

OF

LAND SHARKS OF THE PALM BEACHES, INC.

The undersigned incorporator of 'ese Articles of Incorporation, a natural person competent contract, hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I - NAME
