A-1 AIR CONDITIONING ENTERPRISE INC.**

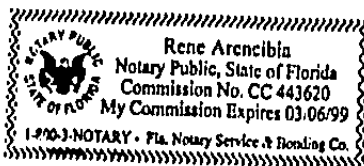
- FIRST:** The name of this corporation is **A-1 AIR CONDITIONING ENTERPRISE INC.**
