

**ARTICLES OF INCORPORATION OF  
C.G.H. ENTERPRISES, INC.**



The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. **Name.** The name of this corporation is **C.G.H. Enterprises, Inc.**
2. **Duration.** The period of its duration is perpetual.
3. **Purpose.** The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.
4. **Capital Stock.** The Corporation is authorized to issue 500 shares, all of one class, at \$1.00 par value.
5. The Corporation shall conduct and operate its business at the following location: 8001 S.W. 55th Place, Gainesville, Florida 32608.
6. **Initial Board of Directors.** This corporation shall have one director initially. The number of directors may be either increased or decreased from time to time by an amendment of the bylaws of the corporation in the manner provided by law, but shall never be fewer than one.
