ARTICLES OF INCORPORATION

OF

MOLY-VEN INTERNATIONAL, INC.

The undersigned, being over 18 years of age hereby subscribes to and files these articles of incorporation to create a corporation under the laws of the State of Florida.

ARTICLE 1

The name of the corporation shall be Moly-Ven International, Inc.

ARTICLE 2

The aggregate number of authorized shares of capital stock of this corporation shall consist of one thousand (1,000) shares of common stock, having a par value of ONE AND NO/100 DOLLAR (\$1.00) per share.

All the stock is payable in cash, property or labor or services at a just valuation fixed by the Board of Directors. Payment is not required at issuance.

ARTICLE 3

This corporation will commence immediately upon the filing of these articles of incorporation and will exist perpetually unless dissolved according to law.

ARTICLE 4

The initial registered office of this corporation is 80 SW 8th Street-Suite 206° Miami, FL 33130. The initial registered agent at that address is David Solomon. Other offices and branch offices can be within or without the State of Florida. The mailing address is 80 SW 8th Street, Miami, FL 33130.

ARTICLE 5

This corporation shall have at least one director. The exact number can be specified by the stockholders from time to time. The stockholders can, by a majority vote, determine that the corporation be managed by the stockholders.

ARTICLE 6

These are the names and addresses of the first directors of the corporation, who will hold office for the first year or until their successors are duly elected and qualified.

ARTICLE 7

No transaction between this corporation and a second party will be affected due to a director, officer or shareholder of this corporation having an interest in the second party. Directors, officers and stockholders of this corporation - and firms in which they are interested - can transact business with this corporation provided a full disclosure of the duality of interest is made to the board of directors of this corporation. Directors can be counted in a quorum of this corporation notwithstanding their duality of interest.

ARTICLE 8

The private property of the stockholders will not be subject to payment of the corporate debts. The corporation will have a first lien on the shares of its stockholders and upon the dividends due them for any indebtedness of the stockholders of the corporation.

ARTICLE 9

This corporation will indemnify and insure its officers and directors to the fullest extent permitted by law.

ARTICLE 10


The purpose of this corporation is to engage in all lawful business including, but not limited to importing, exporting, trading, financing and business consultation.

I, David Solomon, hereby agree to act as registered agent and agree to comply with the Florida law regarding keeping the registered office open.

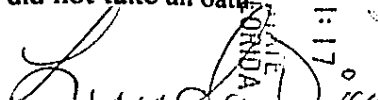

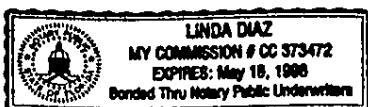
