ARTICLES OF INCORPORATION OF ABRAHAM SCHWARTZ SECULTARY OF STATE TALLAHASSEE, FLORIDA

The undersigned natural person, competent and licensed to practice public accounting in the State of Florida, acting hereby as Incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Section 607, Florida Business Corporation Act, and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

I

Name of Corporation, Principal Office and Mailing Address

The name of this corporation, shall be ABRAHAM SCHWARTZ, P.A.

The principal office of this comporation shall be 5876 S.W. 89th Lane, Cooper City, Florida 33328.

The mailing address of this corporation shall be 5876 S.W. 89th Lane, Cooper City, Florida 33328.

II

Purposes

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

a. To render the practice of certified public accounting to the public, which shall consist of any and all work or duties within the scope of certified public accountants, such as making audits or accounts for and of individuals, proprietors, partnerships, government agencies or bodies or any other persons or organizations; keeping, examining and inspecting financial books and accounts; devising, installing and giving directions for the management of accounting, financial, checking, correspondence, filing and other office systems, methods and forms; investigating fiduciaries and stewardships; compiling commercial and industrial statistics, inventory, balance sheets, income profit and loss, and operating statements; examining the accounts and physical and financial condition of any organization and reporting the same to those interested therein; and warranting the accuracy of the work done on services performed. This professional corporation shall exist and function in compliance with the "Florida Professional Service Corporation Act" (F.S.A. Chapter 621) and in order to properly prosecute the objects and purposes set forth, the Corporation shall have full power and authority to purchase, lease and otherwise acquire, hold, mortgage, convey, and otherwise dispose of all kinds of property, both real and personal, necessary for the rendering of accounting To render the practice of certified public accounting to the public, of property, both real and personal, necessary for the rendering of accounting services.

b. To engage and render the professional services involved only through its officers, agents and employees who shall be certified public accountants in

good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this corporation.

- c. To invest its funds in real estate, mortgages, stocks, bonds and any other type of investments permitted by law.
- d. To engage in no other business other than the rendition of the professional services specified herein.
- e. To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not fortidden under the laws of the State of Florida.

III

Capital Stock

- a. The maximum number of shares of stock that the corporation is authorized to have outstanding at any time shall be five hundred shares of common stock at one dollar (\$1.00) per share par value.
- b. The consideration to be paid for each share shall be payable in lawful money or property, labor or services.
- c. Shares of the corporation's stock and certificates shall be issued only to certified public accountants in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this corporation.

IV

Duration

The corporation shall have perpetual existence.

v

Registered Agent

The address of this corporation's initial registered office is Abraham Schwartz and the name of its initial registered agent at said address is 5876 S.W. 89th Lane, Cooper City, Florida 33328.

VI

Incorporator

The name and address of the Incorporator is as follows:

VII

Board of Directors

The corporation shall have a Board of Directors consisting of one person. The number of Directors may be increased or decreased from time to time by a resolution of the majority of the Stockholders but shall never be less than one. The names and addresses of the initial Directors of this corporation are:

VIII

Informal Shareholder Action

Any action of the Shareholders may be taken without a meeting if consent in writing setting forth the action so taken shall be signed by all the Shareholders entitled to vote upon such action at a meeting and filed with the Secretary of the corporation as part of the corporate records.

IX

Severance and Termination of Employment

If any officer, director, stockholder, agent or employee of this corporation becomes legally disqualified to render the professional services for which the corporation is organized, or accepts employment that places restrictions or limitations on his continued rendering of such professional services, he shall forthwith sever all employment with the corporation, and shall not thereafter participate or share, directly or indirectly, in any earnings or profits realized by the corporation on account of professional services. The corporation shall forthwith, upon such disqualification of any shareholder, purchase such shareholder's shares and pay him all amounts owing and lawfully due to him by the corporation, except that such shares shall not be entitled to dividends.

X

Intormal Director Action

If all of the Directors severally or collectively consent in writing to any action taken or to be taken by the Corporation, and the writings evidencing their consent are filed with the Secretary of the corporation, the action shall be as valid as though it had been authorized at a meeting of the Board of Directors.

XI

Indemnification

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

XII

Bylaw Amendment

The power to adopt, alter, amend or repeal the bylaws of this Corporation shall be vested in the Board of Directors and Stockholders provided that such amendment be in compliance with the laws of Florida governing a Professional Service Corporation.
