- 5. No chareholds of the Corporation may sall or transfer his stock in this corporation except to another individual who is sligible to be a shareholder of the corporation.

ARTICLE XI INDEMNIFICATION

The corporation shall indemnify any officer or director, to the full extent permitted by law.

ARTICLE XII DISSOLUTION
