1. The name of the corporation is Small Support Services, Inc. SECRETARY OF STATE  
TALLAHASSEE, FLORIDA
2. The principal place of business and mailing address of this corporation shall be: 1707 N.E. 38th Avenue, Ocala, Florida 34470.
3. The corporation shall have the authority to issue 1000 shares of common stock, in one class only, each with a par value of \$1.00.
