ARTICLE I. NAME.

The name of this corporation is NATIONWIDE AUTO SALES, INC.

ARTICLE II. NATURE OF BUSINESS.

The nature of business to be transacted by the corporation shall be:

A. To buy, sell exchange, import or export automobiles, automobile accessories, automobile trucks, tractors, and other rolling stock and vehicles of any and every make; to repair, reconstruct, overhaul and improve automobile, automobile trucks, tractors and rolling stock of all kinds and makes. To generally deal in the business of automobile sales and exchange including all related activities.

B. To engage in any activity or business permitted under the laws of the United States or of the State of Florida.

ARTICLE III. CAPITAL STOCK.

This corporation shall have one (1) class of common stock having a par value of One Dollar (\$1.00) per share and the same shall be fully paid and nonassessable. The maximum number of shares of said stock this Corporation is authorized to have outstanding at any one time is Seven Thousand (7,000) shares.

**ARTICLE IV. INITIAL CAPITAL.**

The amount of capital with which this corporation shall begin business is Five Hundred (\$500.00) Dollars.

**ARTICLE V. TERM OF EXISTENCE.**

This Corporation is to have perpetual existence.

**ARTICLE VI. ADDRESS.**

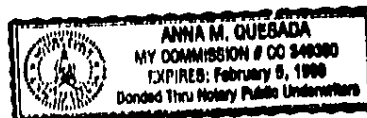
