## **ARTICLES OF INCORPORATION**

**OF**

### **THE GREEN COW LANDSCAPING COMPANY, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

#### **ARTICLE I - THE GREEN COW LANDSCAPING COMPANY, INC.**

The name of the corporation is THE GREEN COW LANDSCAPING COMPANY, INC. Mailing address is 11401A West Palmetto Park Road Suite 218, Boca Raton, Florida 33428.

#### **ARTICLE II - DURATION.**

The duration of the corporation is perpetual.

#### **ARTICLE III - NATURE OF BUSINESS.**

The general nature of the business to be transacted by this corporation is to manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property and services of every class, kind and description; except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telephone, telegraph or cemetery company, a building and loan association, fraternal benefit society, state fair or exposition.

#### **ARTICLE IV - CAPITAL STOCK.**

The aggregate number of common shares which the corporation is authorized to issue is 1,000 shares. Such shares shall have a \$1.00 par value.

#### **ARTICLE V - REGISTERED OFFICE AND AGENT.**

The street address of the initial registered office of the corporation is 22582 S.W. 64th Way, Boca Raton, Florida 33428, and the name of its initial registered agent is Jesse McNeil.

The number of directors constituting the initial board of directors of the corporation is two (2). The name and address of the persons whom will serve as the members of the initial board of directors is:

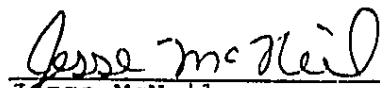

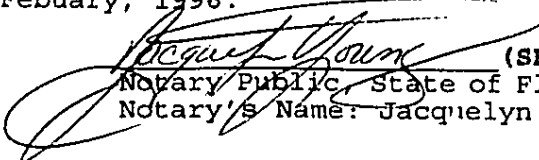
