ARTICLE I - NAME *ADVANCED*

The name of this corporation is Florida Medical Services, Inc. (the "Corporation").

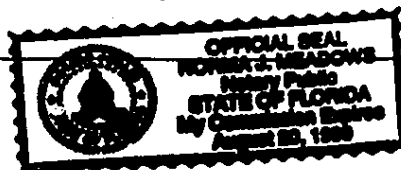
