INDEMNIFICATION



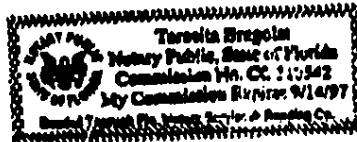
