ARTICLE ONE

The name of the corporation is LRM CONSULTING, INC. The principal address of the corporation is: 7040 N.W. 62nd Terr., Parkland, FL 33067.

ARTICLE TWO

The period of its duration is perpetual.

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations maybe incorporated under the Florida Corporation Act.
