**ARTICLE I

OFFICERS AND DIRECTORS

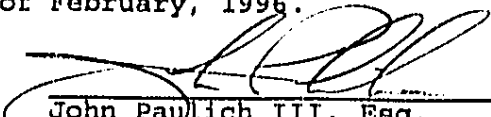

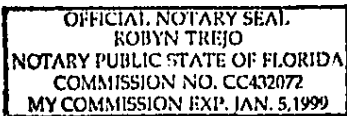

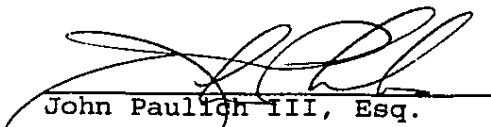
