ARTICLES OF INCORPORATION OF RSF SUPPLY, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is RSF SUPPLY, INC.

ARTICLE II

The duration of the corporation is perpetual.

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.
