

ARTICLES OF INCORPORATION OF SUNCOAST PACKAGING SYSTEMS, INC. 95 FEB 20 AHID: 54

A Florida Corporation

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be: SUNCOAST PACKAGING SYSTEMS, INC.

ARTICLE II

The general nature of the business to be transacted by this corporation is: any and all activity or business permitted under the laws of the United States and the State of Florida, inc;uding the sales and distribution of packaging machines and supplies.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 300,000 shares of common stock with a par value of \$6.01.

ARTICLE IV

The corporation is to exist perpetually.

ARTICLE V

The initial post office address of the principal office of this corporation in the State

of Florida is: 2700 - 67th Avenue South, St. Petersburg, FL 33712.

ARTICLE VI

The corporation shall have two directors initially. The number of directors may be increased or decreased from time to time, by the by-laws adopted by the stock holders.
