ARTICLES OF INCORPORATION ARTICLE ONE

FRITANGA EL ARBOLITO, INC.

The name of this corporation is: FRITANGA EL ARBOLITO, INC.

The principal office and mailing address of this corporation is: 1840 WEST 49TH STREET-STE. #605, HIALEAN, FL. 33012

ARTICLE TWO

NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE THREE

DURATION

This corporation shall have perpetual existence unless sconer dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is: UPON APPROVAL BY SECRETARY OF STATE.

ARTICLE FOUR

CAPITAL STOCK

This corporation is authorized to issue shares of stock as follows:

- A- Designation. The stock of this corporation shall be known as Common Stock.

- G- Dividends. Record holders of Common Stock are entitled to receive their pro-rate share of any dividends that may be declared by the Board of Directors out of assets legally available for such purpose.

The power to adopt, alter, amend or repeal By-Laws shall be vested --either in the Board of Directors or the Shareholders, but the Board of
