The name of the corporation shall be:

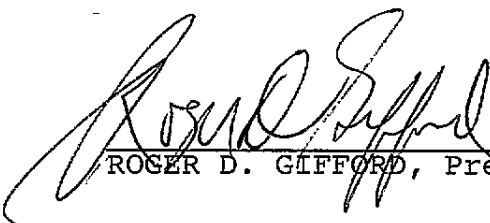
RIVERSIDE PROFESSIONAL BILLING SERVICE, INC."
