OF
CEDAR KEY SECURITIES, INC.

EFFECTIVE DATE
2/28/96

ARTICLE I - NAME

The name of the corporation shall be: **CEDAR KEY SECURITIES, INC..**

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 16690 Anna Street, Post Office Box 85, Cedar Key, Florida 32625.

ARTICLE III - PURPOSE

The corporation may engage in any legal business.

ARTICLE IV - CAPITAL STOCK

The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 1,000 shares of common stock of a par value of \$1.00 per share.
