ARTICLES OF INCORPORATION
OF
DYER'S TOWER SERVICE, INC.

ARTICLE I

The name of this corporation is **DYER'S TOWER SERVICE, INC.**

ARTICLE II

The corporation is to exist perpetually, commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III

This corporation is organized for the purpose of maintenance and service of communication towers and the transaction of all lawful business.

ARTICLE IV

This corporation is authorized to issue Two Thousand (2,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

ARTICLE V

The amount of capital with which this corporation will begin business is Two Thousand Dollars (\$2,000.00).

ARTICLE VI

ARTICLE VII

stock entitled to vote thereon, unless all directors and all stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.


