The undersigned, desiring to form a professional corporation in accordance with the applicable provisions of Chapter 621 of the Florida Statutes for the practice of law, do hereby adopt the following Articles of Incorporation.

ARTICLE ONE

NAME

The name of the corporation shall be:
LAW OFFICES OF SHENNA A. STEVENS, P.A.

ARTICLE TWO

PURPOSES

The purposes for which the corporation is organized are as follows:

(1) Primarily to engage in the specific business of the practice of law as a law corporation;

(2) To engage generally in the business of a law corporation as the same is now or hereafter defined by statute, rule and regulation, and in connection therewith to own property, to enter into contracts, and to transact any lawful business related thereto;

(3) To engage in such other business as may be authorized or permitted by the applicable provisions of Chapter 621 of the Florida Statutes.
