

ARTICLES OF AMENDMENT
OF
CREATIVE SOLUTIONS INTERACTIVE, INC.

Pursuant to the provisions of the Florida Business Corporation Act, the above corporation hereby adopts the following articles of amendment to its articles of incorporation:

1. Name. The name of the corporation is CREATIVE SOLUTIONS INTERACTIVE, INC.

2. Amendment Text. The amendment to the articles of incorporation of the corporation provide as follows:

RESOLVED, that an amendment to the articles of incorporation of the corporation be and hereby is adopted changing the name of the corporation from **CREATIVE SOLUTIONS INTERACTIVE, INC.** to **NEXTDigital, INC.**

3. Date Adopted. The above amendment was duly adopted on the date hereof.

4. Method of Adoption. The above amendment was duly adopted by written consent of all of the shareholders of the common stock (which is the only voting stock), and all of the directors of the corporation on the date hereof.
