The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: McNIEL ASSOCIATES OF WINTER PARK, INC., whose initial business address is 745 Gilbert Drive, Winter Park, Florida 32792.

Article 2. Duration The duration of the Corporation is perpetual.

Article 3. Purpose. The general purposes for which the Corporation is organized are the following:
