ARTICLE ONE, NAME:

The Name of the Corporation is: FARC, INC.

ARTICLE TWO, DURATION:

The term of existence of the Corporation is perpetual; and the corporate existence will commence on the filing of these articles by the Secretary of State.

ARTICLE THREE, CORPORATE PURPOSE:

The purpose for which the corporation is organized is to operate an amateur radio club in the State of Florida

ARTICLE FOUR, DIRECTORS AND MEMBERS:

There shall be four members of the initial Board of Directors of the Corporation. The name and address of the persons who are to serve as Directors until the first election thereof is as follows:


