OF

The undersigned, acting as incorporator of NETWORK EDUCATION CENTERS BROWARD, INC., under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation (the "Corporation") is NETWORK EDUCATION CENTERS BROWARD, INC.

ARTICLE II

STATEMENT OF RESIGNATION OF REGISTERED AGENT


