

ARTICLES OF INCORPORATION

QF

THE UNDERSIGNED INCORPORATOR, EACH A NATURAL PERSON, COMPETENT TO CONTRACT, FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE FLORIDA BUSINESS CORPORATION ACT, HEREBY ADOPT THE FOLLOWING ARTICLES OF INCORPORATION.

ARTICLE I NAME

THE NAME OF THE CORPORATION SHALL BE: STARLING TREE SERVICE, INC.

ARTICLE II ADDRESS

THE INITIAL STREET ADDRESS OF THE PRINCIPAL OF THIS CORPORATION AND ITS REGISTERED OFFICE SHALL BE: 724 58th Street, West Palm Boach, FL 33407

THE OWNERS MAY FROM TIME TO TIME MOVE THE PRINCIPAL OFFICE TO ANY OTHER ADDRESS WITHIN THE STATE OF FLORIDA.

ARTICLE III NATURE OF BUSINESS

THE NATURE OF THE BUSINESS AND THE OBJECTS AND PURPOSES PROPOSED TO BE TRANSACTED, PROMOTED AND CARRIED ON, ARE TO DO ANY OR ALL THINGS HEREIN MENTIONED AS FULLY AND TO THE SAME EXTENT AS NATURAL PERSONS MIGHT OR COULD DO, AND IN ANY PART OF THE WORLD, VIS:

"THE PURPOSE OF THE CORPORATION IS TO ENGAGE IN ANY LAWFUL ACT OR ACTIVITY FOR WHICH CORPORATIONS MAY BE ORGANIZED UNDER THE GENERAL CORPORATION LAW OF THE STATE OF FLORIDA AND THE UNITED STATES GOVERNMENT."

THE PRIMARY BUSINESS TO BE CARRIED ON BY THE CORPORATION IS THE PURCHASING, PLANTING, SELLING, TRIMMING AND REMOVING OF TREES, ETC., AND SUCH OTHER BUSINESS AS MAY BE AGREED TO BY THE OWNERS.

ARTICLE IV CAPITAL STOCK

THE MAXIMUIM NUMBER OF SHARES OF STOCKS THAT THIS CORPORATION IS INITIALLY AUTHORIZED TO HAVE OUTSTANDING IS <u>1000</u> SHARES OF STOCK. THE OWNERS AUTHORITY TO ISSUE ADDITIONAL SERIES AND CLASSES OF STOCK PURSUANT TO THE PROVISIONS OF THE LAW AND BY-LAWS OF THE CORPORATION.

ARTICLE V INITIAL CAPITAL

THIS CORPORATION SHALL BEGIN BUSINESS WITH THAT AMOUNT OF CAPITAL DEEMED NECESSARY BY THE OWNERS.

ARTICLE VI TERM OF EXISTENCE

THIS CORPORATION SHALL HAVE PERPETUAL EXISTENCE UNLESS DISSOLVED BY ACTION OF LAW.

ARTICLE VII OWNERS

THIS CORPORATION SHALL HAVE NOT LESS THAN FOUR (4) OWNERS INITIALLY. THE NUMBER OF OWNERS MAY BE CHANGED FROM TIME TO TIME, BY THE BY-LAWS ADOPTED BY THE OWNERS.

ARTICLE VIII OFFICERS

THE OFFICERS OF THIS CORPORATION SHALL BE A PRESIDENT, A SECRETARY, A TREASURER, AND SUCH OTHER OFFICERS AS MAY BE DEEMED NECESSARY BY THE OWNERS. ALL SUCH OFFICERS SHALL BE CHOSEN IN SUCH MANNER, HOLD THEIR OFFICES FOR SUCH TERMS AND HAVE SUCH POWERS AND DUTIES AS MAY BE PRESCRIBED BY THE BY-LAWS OR DETERMINED BY THE OWNERS.

ARTICLE IX AMENDMENT

THESE ARTICLES OF INCORPORATION MAY BE AMENDED IN THE MANNER PROVIDED BY LAW. EVERY EMENDMENT SHALL BE APPROVED BY THE OWNERS SIGNING A WRITTEN STATEMENT MANIFESTING THEIR INTENTION THAT CERTAIN AMENDMENT OF THESE ARTICLES OF INCORPORATION BE MADE:
