ARTICLES OF INCORPORATION OF BRIGDON, INC.

ARTICLE I. NAME

The name of this corporation shall be BRIGDON, INC.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Division of Corporations. This corporation's duration shall be perpetual.

ARTICLE III. PURPOSE
