We are a new Florida Corporation with limited employees and funds. In January of 1997 it was necessary to move our corporate offices from 7256 Westwind Drive, Spring Hill, Fl. 34609. Since most of our accounts were in Ft. Myers, we moved to the above address in Cape Coral, Fl. 33409.
