

I, RONALD E. DOBELSTEIN, the undersigned, heroby execute these Articles of Incorporation for the purpose of becoming a professional association under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation, rights, privileges, immunities and liabilities of professional associations for profit.

ARTICLE I

The name of the professional association is:

RONALD E. DOBELSTEIN, P.A.

ARTICLE II

The general nature of the business to be conducted shall be:

LEGAL SERVICES

The professional association may engage in any activity or business permitted under the laws of the United States of America and the State of Florida.

ARTICLE III

The maximum number of shares of stock that this professional association is authorized to have outstanding at any time is 100 shares of common stock of a ONE DOLLAR (\$1.00) par value. All of said stock and the value thereof are issued in accordance with Section 1361 and 1244 of the Internal Revenue Code and the regulations issued thereunder, and said offering of this stock

under said provisions of the Internal Revenue Code is to continue for so long as permissible pursuant to the Internal Revenue Code.

ARTICLE IV

This professional association shall have perpetual existence.

ARTICLE V

The initial street address of the principal office of this professional association shall be 8370 SW 91 Street, Miami, Florida 33156. The Board of Directors may, from time to time, designate such other post office address and place of the principal office of this professional association as it may see fit.

ARTICLE VI

The number of Directors of this professional association shall be as provided by the By-laws, but shall not be less than One (1) in number, nor more than Three (3), and shall be one in number until otherwise fixed or changed by the By-laws.

ARTICLE VII

The names and addresses of each subscriber to these Articles of Incorporation, and the number of shares of stock which each agrees to take, are as follows:

ARTICLE X



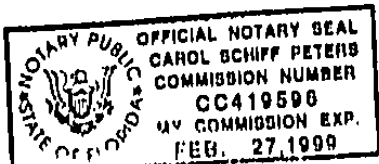

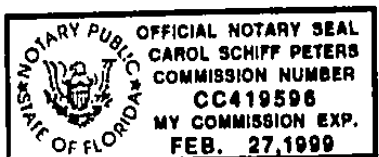
