# ARTICLES OF INCORPORATION

OF

### RONALD E. DOBELSTEIN, P. A.

I, RONALD E. DOBELSTEIN, the undersigned, hereby execute these Articles of Incorporation for the purpose of becoming a professional association under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation, rights, privileges, immunities and liabilities of professional associations for profit.

### ARTICLE\_I

The general nature of the business to be conducted shall be:
