ARTICLES OF INCORPORATION  
OF  
HOBO'S BAR.B.QUE., INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the Corporation is HOBO'S BAR.B.QUE., INC.

ARTICLE TWO

DURATION

The term of existence of the Corporation is perpetual.

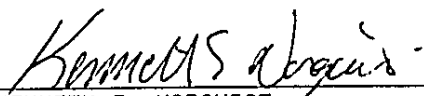

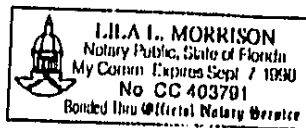
