The undersigned subscriber to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation for profit under the laws of the state of Florida.

ARTICLE I

The name of the corporation is: R & T Marketing Co.

ARTICLE II

This corporation may engage in any activities or businesses permitted under the laws of the state of Florida and the United States.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is 5000 shares of common stock with nominal par value. All or any part of said stock of this corporation may be paid for wholly or in part for cash or for the purchase of property, patents, contracts, labor or services at a just valuation to be fixed by the directors of this corporation at any regular or special meeting and any and all shares so issued shall be paid fully paid and nonassessable.

ARTICLE IV

The amount of capital which this corporation shall begin business shall not be less than FIVE HUNDRED DOLLARS (\$500.00).

ARTICLE V

This corporation is to exist perpetually unless dissolved in accordance with the laws of the state of Florida.

ARTICLE VI

The initial street address of the principal office of this corporation in the state of Florida is: 6417 Ridgeberry Dr. Orlando, Florida, 32819. The board of Directors may from time to time move the principal office to any other address in Florida. This corporation shall have the privilege of having such branch offices at such other places within or without the United States of America as may be designated from time to time by the Directors of the Corporation.

ARTICLE VII

This corporation shall not have less than one (1) director initially; the number of directors may be increased or diminished from time to time by Bylaws adopted by the stockholders, but shall never be less than one (1).

ARTICLE VIII

Pursuant to Chapter 48.091, Florida Statutes Tulay swank whose address is 6417 Ridgeberry Dr, Orlando Fl, 32819 is hereby named as agent of this corporation to accept services of process within the state of Florida; The said Tulay Swank by execution of these articles, does accept to act in this capacity and agrees to comply with the provisions of said Act relative to keeping open said offices located at the above address.

These Articles of incorporation may be amended in the manner provided by law. Every amendment shall be proposed by the stockholders, and approved at a stockholder's meeting by a majority of the stock entitled to vote thereon, unless all the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of incorporation be made.
