The undersigned, acting as Incorporator, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I NAME

The name of this corporation is FLORIDA RESEARCH CONSULTANTS, INC.

ARTICLE II **DURATION**
