**ARTICLES OF INCORPORATION
OF
THE PLANET INK COMPANY**

The undersigned acting as incorporator of a corporation under the Florida General Corporations Act adopts the following Articles of Incorporation of such corporation.

ARTICLE I

The name and mailing address of the corporation is THE PLANET INK COMPANY, 1873 North Tamiami Trail, North Fort Myers, Florida 33903

The period of its duration is perpetual.

The number of directors constituting the initial board of directors is five, whose names and addresses are:

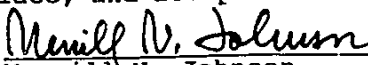

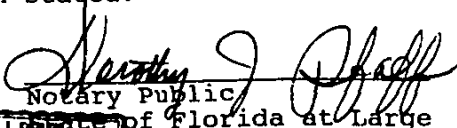
