

ARTICLE I--NAME

The name of this corporation is BRAMANS RAW BAR & GRILL, Inc.

ARTICLE II--DURATION

This corporation shall have perpetual existence commencing on upon the filing of these Articles.

ARTICLE III--PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV--CAPITAL STOCK


