ARTICLES OF INCORPORATION

OF

THE UNDERSIGNED, acting as solu incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of incorporation for such corporation:

ARTICLE

The name of the corporation shall be: DBM REAL ESTATE VENTURES, INC. The address and mailing addess of the corporation's principal office shall be:


