The undersigned, EDWARD J. OBST, for the purpose of forming professional corporation under Chapter 621 of the Florida Statutes and the Florida Professional Service Corporations act, hereby adopts the following Articles of Incorporation.

ARTICLE I

NAME

The name of the corporation shall be:

ARTICLE II

DURATION

The term of existence of the corporation is perpetual.

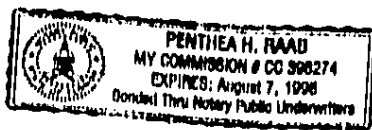
