ARTICLES OF INCORPORATION

or

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is **OUR HOUSE OF STYLE, INC.**SECOND: The period of duration of the corporation is perpetual.
