# ARTICLES OF INCORPORATION OF

ARLINE MAE TABLER, P.A.

# **ARTICLE I - NAME**

The name of this corporation is ARLINE MAE TABLER, P.A.

# **ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing on the date of signing.

# **ARTICLE III - PURPOSE**
