ARTICLE I
Name

The name of this Corporation is A AFFORDABLE FABRICATION, INC.

ARTICLE II
Principal Office

The principal office of this corporation shall be 5991 Chester Ave., Suite 109, Jacksonville, Florida 32217.

ARTICLE III
Duration

This corporation shall have perpetual existence.

ARTICLE IV
Purposes and Powers

The nature and purposes of the business to be carried on by A AFFORDABLE FABRICATION, INC., are to engage in the fabrication, sale, installation, and repair of fiberglass products and in any activity or business permitted under the laws of the United States and of the State of Florida.

The corporation shall have all powers of a general corporation for profit under Chapter 607, Florida Statutes, or any amendment thereto.

ARTICLE V
Capital Stock

The maximum number of shares of capital stock which this corporation is authorized to issue or to have outstanding at any one time is 1,000,000 shares of common capital stock having a par value of One Dollar (\$1.00) per share.
