ARTICLES OF INCORPORATION

OF

ROGALE, INC.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I. NAME.

The name of the corporation is ROGALE, INC.

ARTICLE II. PRINCIPAL OFFICE AND REGISTERED AGENT.

The principal office of the Corporation is at 101 Sugar Bear Dr., Safety Harbor, Florida 34695 in Pinellas County, State of Florida. The registered agent at this address is CARL FYHRIE.

ARTICLE III. DURATION.

The Corporation shall have perpetual existence.

ARTICLE IV. NATURE OF BUSINESS.

The general nature of the business to be transacted by this corporation is to buy, sell, rent and otherwise deal in real property, and any other activities or business permitted under the laws of the Urited States and the State of Florida.

ARTICLE V. POWERS.

Section 2. Pre-emptive rights.
