**ARTICLE I - NAME**

The name of this corporation shall be: ARROWHEAD AQUATIC SUPPLY, INC., and its principal office and mailing office is 19019 Boyette Road, Lithia, Florida 33547.

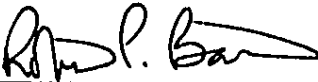
