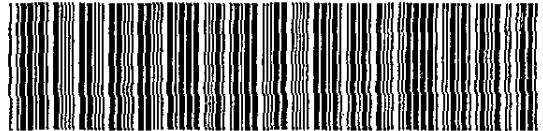



**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION  
OF  
GINGERICH TRUCKING, INC.**
