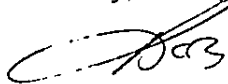

ARTICLES OF INCORPORATION

OF

PASCHA MARINE, INC.

Article I - Name

The name of this corporation is Pascha Marine, Inc.

Article II - Duration

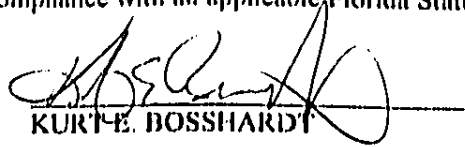
