ARTICLES OF INCORPORATION OF

MATANZAS INTERNATIONAL RESOURCES, INC.

The undersigned, for purposes of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is MATANEAS INTERNATIONAL RESOURCES, INC.

ARTICLE THO

The duration of the corporation shall be perpetual.

ARTICLE THREE

The general purpose for which the corporation is organized is to engage in the business of international consulting work and any and all such related enterprises, and to transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act, and to do all things as are necessary or desirable in order to accomplish the foregoing.

ARTICLE FOUR

The aggregate number of shares which the Corporation is authorized to issue is 100 at One Dollar (\$1.00) per share.

The number of directors constituting the initial Board of Directors of the corporation is one(1).
