

## ARTICLES OF INCORPORATION OF

PALM STATE ENTERPRISES INC.



The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of Corporation is: PALM STATE ENTERPRISES INC.

Article 2. Duration. The duration of the Corporation is perpetual. FL34224.

Article 3. Purpose. The general purposes for which the Corporation is organized are:
