The name of this corporation is Hurricane Offshore Racing, Inc.

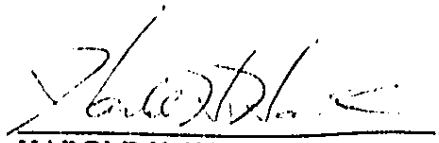
Article XI - By-Laws

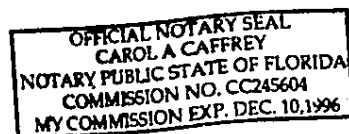

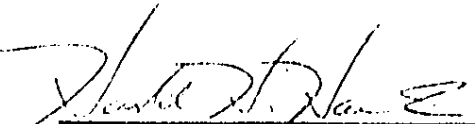
