ARTICLES OF INCORPORATION OF TRADEWINDS CONSOLIDATIONS INC.

ARTICLE I-NAME: The name of this corporation is:
TRADEWINDS CONSOLIDATIONS INC.

ARTICLE II-DURATION: The corporation shall have a perpetual existence.

ARTICLE III-PURPOSE: The general purpose of the corporation is to engage in the business of real estate management and consulting, and related activities, and any other business and commercial activities and business permitted under the laws of the United States of America and of the State of Florida.
