ARTICLE IV

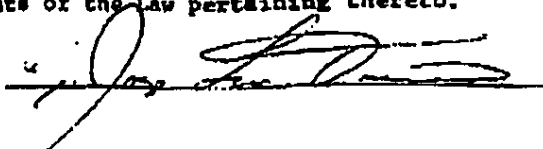
All shareholders of the Corporation shall be Vested with full preemptive rights.

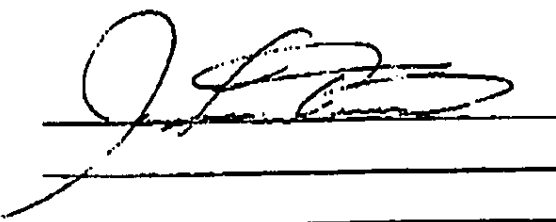
